DYFED-POWYS ELECTED LOCAL POLICING BODY DISCLOSABLE INTERESTS

NOTIFICATION OF PERSONAL AND PECUNIARY INTRESTS FORM POLICE AND CRIME COMMISSIONER

In this notification of disclosable interests: -

"body in which the relevant person has a beneficial interest" means a firm in which the relevant person is a partner or a body corporate of which the relevant person is a director, or in the securities of which the relevant person has a beneficial interest;

"director" includes a member of the committee of management of an industrial and provident society;

"land" includes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;

"elected local policing body" means the elected Local Policing Body to which the relevant person is a volunteer of;

"personal and pecuniary interests" include your interests and the interests of your spouse, civil partner or a person you are living with as if they were your spouse or civil partner;

"relevant period" means the period of 12 months ending with the day on which the relevant person makes an entry, amendment or deletion to the register of disclosable interest;

"relevant person" means the person who is/are elected as Police and Crime Commissioner who is making the notification of disclosable interest set out below;

"securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

"sensitive interest" means an interest deemed by the Monitoring Officer to be a "sensitive interest" on the relevant person raising concern that the inclusion of the interest on the register of interests made publicly available would lead to the relevant person or a person connect with the relevant person being subject to violence or intimidation and the relevant person has requested the Monitoring Officer to agree that the interest is a "sensitive interest".
